TR-01-C-0837, used in the office of the Medical Superintendent, A.G.M.C & G.B.P. Hospital, Agartala."

Terms and Conditions

1. Sealed quotations in two cover system, i.e., i. Technical bid and ii. Financial bid should reach the Office of the Medical Superintendent, A.G.M.C & G.B.P. Hospital, Agartala on or before 4:00 pm of 27/07/2020 By Speed post/courier/registered post only.
2. The sealed quotation should be addressed to "The Medical Superintendent, Agartala Government Medical College & G.B.P. Hospital, P.O.-Kunjaban, Agartala, Tripura West, 799006." And on top of the sealed envelope it should be super-scribed as *Quotation for* "Repairing of the Vehicle (Maruti Gypsy) Registration no. TR-01-C-0837."
3. Demand draft on any scheduled Bank having branch in Agartala for an amount of @1,000/- (One Thousand) in the name of the Medical Superintendent, A.G.M.C & G.B.P. Hospital, Agartala, payable at Agartala, shall have to be submitted towards Earnest Money Deposit (EMD), which will be treated as security deposit in case of successful bidder and will be released after the repairing work is successfully completed, unless the same is forfeited; and for unsuccessful bidders, it will be released after finalization of tender.
4. Quotations received after the due date and time shall be rejected. The undersigned shall not be responsible for any postal delay, etc.
5. The bidders should provide the name of the Firm/Authorized Distributor/Workshops, contact address, telephone/mobile number and e-mail id (if available) inside the sealed envelope. Quotations received duly will be opened in the AGMC Council Room on, during which bidders or their authorized representatives may remain present.
6. The bids should be submitted in two separate sealed envelopes inside a sealed cover envelope. The contents of the bids should be as:

a. Technical bid:


- i. Photocopy of Relevant valid trade license.
- ii. Photocopy of valid PAN Card.
- iii. Photo copy of valid GST Registration.
- iv. Photocopy of the Bank Passbook showing A/c number and IFSC.

b. Financial bid:

Welding Service charge to be quoted in the following format.

6. Payment of Bill through DBT mode will be made after successful completion of work, on satisfaction of the Superintendent Central Workshop and also of the Driver of the Vehicle.
7. Income tax/GST will be deducted from the bill at the time of payment as per Govt. rule.
8. If any of the certificates/documents furnished by the Bidder is found to be false / fabricated / bogus, the bidder shall be liable to blacklisted, apart from legal actions.
9. Work shall be completed within 7 (Seven) days from date of issue of work order. However, relaxation may be made only in special circumstances like natural calamities, war or any other situation beyond human control. Delay in executing the work shall result in imposition of penalty @1% for every week of delay or part thereof.
10. No interest can be claimed in case of delay in making payment beyond the stipulated period of payment.
11. The SNIQ can be cancelled at the discretion of the Medical Superintendent, AGMC & GBP Hospital, Agartala, without assigning any reason therefor.
