Short Notice inviting quotation in sealed cover two bid system(Technical Bid & Price Bid) is invited by the Principal Investigator of the project entitled "A National Model to Measure Burden and Map Quality of Care for Type 2 Diabetes Mellitus in Rural Population in India, involving Medical Collage through Primary Health Care Setup", from the reputed firm/authorized distributor for Supply of Glucose Powder.

Rate should be quoted in the prescribed format as given bellow in the Notice.

The last date of receiving quotation is up to 4 p.m of 25-09-2021 by registered post/ Speed post/ Courier services.

Name of the item for which rate quotation has to be asked and specification also enclosed with the quotation.

Specifications:*

- 1. The product supplied should contain FSSAI approval with valid number and ISO certified.
- 2. Each bottle should contain 1000 gms of glucose powder with 99.4% of Dextrose Monohydrate.
- 3. Calcium Phosphates and Vitamin D may be present along with Dextrose Monohydrate.
- 4. Items supplied should have minimum expiry date of 24 months from the date of manufacture.
- 5. Items supplied should have expiry date of minimum 20 months from date of supply and used within expiry date.
- Items should be supplied in a sealed container without any damage.
- The product supplied should have specific instruction of their storage in cool and dry place without refrigerator.
- 8. Each Bidder should submit a packet of sample along with bid.

Terms and Conditions

1. Quotation in sealed cover for two bid system(Technical Bid & Price Bid) address to the Principal Investigator, Department of Community Medicine, AGMC should reach on or before 4.00 PM of 25th Aug,21 by Speed Post/Courier/Registered Post only.

2. Quotation received after stipulated date & time will be rejected.

3. On the top of envelope, Supply of Glucose powder should be mentioned and Quotationer's full name and address with phone number and S.T.D. code should also be mentioned on the envelop.

4. The quotation should mention the rate of each item distinctly. Correction over use of correcting fluid in the figure, words will not be entertained/accepted.

- 5. The rate should be quoted inclusive of all GST and supply should be made on F.O.R. door delivery basis.
- 6. The evaluation of the bids should not be based on criteria on lowest cost alone but the quality should also be considered.
- 7. No enhancement in rates within the validity period of contract will be entertained.
- 8. The Quotation will be accepted on lowest rate and high quality basis.
- 9. The Quotation will remain valid for one year from the date of approved list.
- 10. Supply should be completed within 30(Thirty) days from the date of issue of supply order.
- 11. A penalty @ 1% of total value must be charged for every week or part of week delay beyond the stipulated period.
- 12. Income Tax will be deducted from the bill at the time of payment as per Govt. Rule.
- 13. If any items supply is found to be standard quantity, the quantity "Not of Standard quantity items" supply should be taken back and fresh stock at own cost of supplier.
