I am directed to state that the Board of Governors considered the Council Assessor's Report(s) (25th April, 2019) on the standard of examination and other teaching facilities for Renewal of Recognition of MD(Anaesthesiology) qualification for 2 seats in respect of students being trained at Agartala Govt. Medical College, Agartala, Tripura granted by Tripura University and Committee decided as under:-

"The Board of Governors considered the Council Assessor's Report (25th April, 2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Anaesthesiology) qualification for 2 seats granted by Tripura University in respect of students being trained at Agartala Govt. Medical College, Agartala, Tripura be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
